PLEASE READ THE TERMS OF SERVICE CAREFULLY

The following outlines the terms and conditions in brief. [Please also check the terms and conditions in full on our website](#). By signing this agreement it is assumed that you have read and understood the full terms and conditions of this agreement.

This Rental Agreement is entered into between Kigali Motorbike Rental Ltd (TIN 113304475) (hereafter KMR) and the Rentee. It outlines the respective rights and obligations of the parties relating to the rental agreement.

1. **RENTAL AGREEMENT:** Kigali Motorbike Rental Ltd hereby agrees to rent to the Rentee the bike(s) requested or one of similar specification for the duration requested. This agreement starts from the date and time that the vehicle(s) is picked up to the time it is returned to KMR and all terms of this agreement have been satisfied by both KMR and the Rentee. The Rentee understands they have no ownership over the rented vehicle or accessories and cannot dispose of them in any way. All bikes and accessories remain the legal property of KMR.
2. **SCOPE OF USE:** The bike(s) is for personal use only and may not be sublet or lent to any third party. The Renter agrees to comply with all local laws and regulations in Rwanda or any other country they drive the vehicle in. The Rentee(s) must be of legal age to drive and possess a valid driving license in English, French, Kinyarwanda or Swahili. The Rentee must carry with them their driving license, ID, and the vehicle's yellow card and insurance documents at all times whilst driving the vehicle.
3. **RENTAL FEES:** A rental period of 1 day is equivalent to 24 hours. Rental fees must be paid in full on the day of pick-up and before the bike is released. For long-term rentals a monthly payment date will be agreed and must be adhered to.
4. **DEPOSIT:** In order to finalise reservations, the Rentee must pay 20% of the total rental price as a deposit. This deposit is refundable, minus transfer costs, if cancelled within one week (seven days) of the start date and non-refundable after.
5. **SECURITY DEPOSIT:** A security deposit of \$50 for scooters and \$100 for motorbikes must be included with rental payment. This will be held to cover damage and reimbursed if the bike is returned without damage.
6. **INSURANCE:** KMR provides third-party insurance on all bikes. Fully comprehensive insurance is available at extra cost and the Rentee must pay COMESA insurance if crossing borders. Third-party insurance covers damage to third parties, but the Rentee is liable for all damage cause to the bike(s) and theft.
7. **INDEMNIFICATION:** The Rentee is liable for any costs incurred during their rental period as relates to legal action, speeding fines, parking fees and medical costs. All Rentees must provide a valid driving license at the time of booking. KMR is in no way liable for fraudulent documents provided by the Rentee or for road violations or reckless driving undertaken by the Rentee. KMR is not responsible for, and is separate from, the Rentee for all legal purposes. The Rentee has an obligation to inform the police of any accident involving a third party, be that another vehicle, livestock or human being.
8. **KMR's RESPONSIBILITIES:** KMR is responsible for maintaining all bike(s) and ensuring that they are roadworthy and in good condition at the time of rental. The Rentee has been afforded the opportunity to inspect the vehicle before departure. KMR has on record a copy of all Rentees' driving licenses, photographic ID, and contact details, including emergency contact details. These details may be provided to third-party authorities in the event of an accident or legal action.
9. **RETURN OF BIKE:** All bikes must be returned with a full tank of petrol. Any damage to the bike must be declared and a full inspection of the bike will be undertaken before the security deposit is returned. The Rentee is liable for any damage incurred to the bike. Bikes

that are returned without a full tank, even if the fuel gauge is displaying full, will result in a \$10 penalty. Bikes that are returned early are not eligible for a refund but may result in a discount on your next rental at KMR's discretion.

10. LATE-RETURN PENALTIES: Bike rental may be extended by contacting KMR 24-hours in advance of the end of the rental agreement and transferring the required rental fee. However, KMR is entitled to refuse an extension if the requested bike has already been booked by another client or is due for a service. Bikes that are returned late without prior agreement incur the following late-return penalty: \$5 per hour for scooters and motorbikes up to 300cc, \$10 per hour for motorbikes above 300cc.
11. DAMAGE: Light damage will result in a charge of \$25. Moderate damage will result in a charge of \$50. Severe damage, which requires the bike to be at the mechanic's for more than three days, will result in a charge of \$100. Phone holder nubs are charged at \$2 per piece. Flat tyres will be charged at \$20 each unless the Rentee replaces the tyre themselves with a brand new inner tube. For all damage except for a flat tyre, the Rentee agrees to return the bike to KMR to be repaired by trusted mechanics. If damage to the bike is so severe that the Rentee cannot continue on their journey, they must contact KMR first before taking the bike to a garage. KMR may agree to send a mechanic to repair the bike. If this is not possible, KMR may replace or reclaim the bike at their discretion.
12. JURISDICTION: In case of any dispute, the laws of the Republic of Rwanda will interpret this rental agreement. If any part of this agreement is found to be unenforceable by a court of law, the remainder of the agreement still has full effect.

The person signing this contract accepts responsibility for all Rentees named on page one of this agreement, and for all damage or loss incurred by any third-party using the vehicle during the rental period, whether named in this agreement or not.

A security deposit is required in order to complete your booking. The deposit is \$50 for scooters and bikes up to 180 cc and \$100 for bikes above 180 cc. This deposit is refunded on the safe return of the bike.
